## CONDITIONS OF ACCREDITATION

The safety essential on our event, imposes drastic measures concerning the conditions of media accreditation. To allow the follow up of this event by the largest number, the organization committee of the Alsace Rallye Festival and the press officer propose two options:

### **PRESS PACK (off site internet)**

Conditions :

- Be a holder of a professional press card
- Or prove the exercise of a professional activity (**except press: SIRET number, professional third party insurance...**)
- Or prove a letter of credit with makes dizzy of the media specifying the identity of the person called to cover the event.

**Attention:** The FFSA Media pass is not accepted on this event.

This pack offers you:

- **Access to the media rooms during the event**
- **Access to the media release**
- **A media book** (with maps, schedule...)
- **A pass**
- **The Rallye plate**
- An individual media chasuble will be delivered by the press service against a personal guarantee of 50 €

Precision: Number of chasuble is limited of 2 per media

### **PACK MULTIMEDIA (sites Internet)/MULTIMEDIA PASS (internet site)**

Open for one person justifying an activity with purpose of information connected to the event. This one will have to supply necessarily a letter of credit with make dizzy individual and/or his responsible to cover this event.

- **Access to the media rooms during the event**
- **Access to the media release**
- **A media book** (with maps, schedule...)

*Each accreditation request (by e-mail) has to reach us at the latest 07/08/2022. Beyond this date, all request will be refused.*

*Each person asking for an accreditation as to show the required documents and has to respect the safety rules.*

**No accreditation for commercial photographs, video maker and internet side holder (except an agreement with the organization)**

**The Organization committee and the Media Office take the right to refuse or retire an accreditation without any justification.**
